- As a Party to CMS, your country will be able to contribute significantly to the conservation of migratory species.
- CMS acts as an **umbrella convention** and encourages development of special agreements for species with an unfavourable conservation status that would benefit from international cooperation.

WHY BECOME A PARTY ?

Initiating the accession process for CMS exhibits **national determination** toward international collaboration on the conservation of migratory species.

As a Party to CMS your country would:

- ❖ demonstrate **its commitment to the conservation of migratory species**, including sustainable use, on a global scale;
- ❖ **strengthen national legal and technical capacity** to utilize valuable natural resources sustainably while at the same time ensuring the conservation of mfor the benefit of future generations;

- ❖ foster regional and international co-operation on MS allowing the sharing of information and building consensus among countries with similar challenges and objectives;
- ❖ gain improved access to relevant technologies and data and benefit from a regular exchange of information and expertise;
- ❖ participate in regular meetings of the COP, where decisions are taken on such important matters as the allocation of financial resources, the listing of species on Appendices I and II and conservation programmes to protect them;

- ❖ be eligible to participate in the work of the various other organs of the Convention, such as the CMS Scientific Council, Standing Committee and ad hoc working groups;
- ❖ have access to funding for research, conservation and capacity building projects; and
- ❖ Contribute to addressing a number of cross-cutting issues.

Benefits of being a CMS Party

- Access to fora of specialists in the management and conservation of MS
- Coordination between the academic sector and the ministries to maximize cooperation and resource use
- Reduced annual contribution
- Simplified National Reports (*on-line*)
- Financial support of eligible delegates to the COP and ScC meetings
- Access to CMS Small Grants Fund for research, conservation and capacity building (US\$ 20,000 - US\$ 40,000)

CMS provides funds for conservation projects

- The projects are proposals of the Scientific Council and the Conference of the Parties (COP)
- Guidelines to solicit funds for projects are available from the CMS Secretariat in Bonn
