SELECTION OF THREE ADDITIONAL EXPERTS TO THE TECHNICAL COMMITTEE

1. Article VI (1) of the Gorilla Agreement specifies the composition of the Technical Committee to be as follows:

- a) One representative of each Range State of the Agreement;
- b) One representative from GRASP (Great Apes Survival Partnership);
- c) One expert from each of the following fields:
 - forest management and conservation
 - environmental law
 - wild animal health

2. According to Article VI of the Agreement, these experts, like the other members of the Technical Committee shall, *inter alia*:

- provide scientific and technical advice and information to the Meeting of the Parties, and, through the Agreement secretariat, to Parties; and
- make recommendations to the Meeting of the Parties concerning the Action Plan, implementation of the Agreement and further research to be carried out.

3. The First Meeting of the Parties, in December 2008, adopted Resolution 1.2 on the Establishment of a Technical Committee (UNEP/CMS/GOR-TC1/Inf3.2). *Inter alia*, this resolution requested the Parties as well as non-Party Range States to propose three experts to the Technical Committee in accordance with Article VI 1(c) of the Agreement for consideration by the Second Meeting of the Parties.

4. The Range State and GRASP representatives were selected by their governments and organizations, and convened for the first time at the first Meeting of the Technical Committee in March 2011. The Committee considered the issue of choosing the three additional experts, and resolved to nominate qualified candidates for the position. These nominations would be received by the Interim Secretariat, and presented to the 2nd Meeting of the Parties for a final decision.

5. In their deliberations, the Technical Committee identified the following desirable attributes for the three positions:

- Wild Animal Health
The expert should be a veterinarian with a good record of publications, and previous experience of having served on an international expert group. He or she should have

led major initiatives in his or her field, and have detailed knowledge about Ebola and other diseases relevant to gorillas.

- **Environmental Law**
The expert should have extensive experience with law enforcement in order to be able to address the threats of poaching and illegal trade, and be in a position to engage at the both the international, as well as the field level. It was suggested that the expert could also be a functional position within law enforcement institution rather than a particular individual.
- **Forest Management and Conservation**
As this is the broadest category, the Committee was less specific about the desirable attributes; however, they agreed that the candidate should possess appropriate qualifications, and practical experience.

6. Following the first Meeting of the Technical Committee, the Interim Secretariat sent a formal request to all Parties and other range states, reiterating the request, and set a deadline for reception of nominations of 120 days before the MOP, being 29 July, 2011.

7. The Interim Secretariat received a total of 17 nominations for the three positions, from five members of the Technical Committee, being; Central African Republic, Democratic Republic of Congo, Republic of Congo, Uganda and GRASP. The details of the candidates are outlined in Annex 1.

8. As agreed by the Technical Committee, the Interim Secretariat consulted with the IUCN Primate Specialist Group (Section on Great Apes) on the suitability of the candidates. The PSG has provided the “rationale” contained in Annex 1.

Action requested:

- The Parties are requested to consider the information contained in Annex 1, deliberate on the suitability of the candidates and select one for each category of additional experts to the Technical Committee.
